I thank the teachers for all their organisation and effort in preparing for the Parent/Teacher Meetings.

#### Cyber Safety

We have seen an increase in the number of children, reporting to teachers, that they are experience negative online behaviours at home. These include being excluded from online chats and games and nasty messages. Please be aware that online behaviours outside school hours, are the responsibility of parents/guardians. These are some recommendations to ensure your child is engaging in positive online behaviours:

- Be aware of what your children are doing when online and who they are engaging with
- Ensure your children are on age appropriate sites
- Children should only use devices in "public" areas of your home e.g. the kitchen, dining room, lounge. Children should not be on devices in their bedroom
- Devices should be turned off at night
- Devices should not be kept in children's bedrooms overnight

## Acting Assistant Principals Message

<u>Catholic Community Week</u> – Next week, and every subsequent Week 7 each term, we will engage in Catholic Community Week at St Therese's. This is a renaming and reshaping of what used to be our 'Wellbeing Week'. This is an essential reminder that it is our faith in and following of, Jesus Christ, that is at the heart of our Catholic community. It is this unity in faith, purpose and vision that allows us all to feel a sense of belonging and connection. In short, as people of faith, we cannot separate our wellbeing from our Catholicity. In fact, it is our Catholic faith and community that should be at the heart of what keeps us well. Every Catholic school and every Catholic school teacher will, and should, tell you that it is this holistic development: the spiritual, the physical, the social & emotional, and the intellectual development of each and every child that inspires our mission.

Next week, we will aim to slow down and take a closer look at each of these 4 dimensions and how we are attending to their growth and development, not just in our children, but also within ourselves.

<u>Office of Safeguarding</u> - Keeping our children safe can be achieved by ensuring our children are informed about their rights and participate in decision-making. Adults need to ensure they listen actively to children and engage them in discussions. This will help children feel valued and respected, which will help them to speak up if they feel they are unsafe or have been abused. At St Therese's, the voice of each child is respected and valued, we have many opportunities for children to be involved in teams and activities to build our community. Encourage your child to participate in these activities such as:

- Lunch/Recess clubs
- · School band for Years 3-6
- · Leadership Teams
- · Aerobics Teams

We have many wonderful children who come to see me or Mrs Maretich, with ideas about school lunch activities such as colouring-in, puzzles etc. These children help to build our school community, so that we continue to keep all our children safe.

**Parent Teacher Meetings** – This week, Parent-teacher meetings are underway for students in Grades 1-6. These are a great opportunity to meet your child's teacher, build positive and collaborative working relationships for the benefit of your child, and to establish achievable goals, relevant to your child's needs. 

- The Diocese of Maitland-Newcastle Catholic Schools Office (CSO), both independently and through its schools, collects personal information, including sensitive information, about students and parents or guardians before and during the course of a student's erroiment at the school. This may be in writing or in the course of conversations. The primary purpose of collecting this information is to enable the school to provide schooling to students enrolled at the school, exercise its duty of care, and perform necessary associated administrative activities, which will enable students to take part in all the activities of the school.
- Some of the information we collect is to satisfy the CSO and the school's legal obligations, particularly to enable the CSO and school to discharge its duty of care.
- Compass is the diocese's centralised digital student information management system and CeD3 is our centralised digital storage system. Compass is owned and operated by a third-party service provider (JDLF International) and CeD3 is owned and operated by the Catholic Education Network (CEnet). The personal information in the system is accessible by:
  - Compass, for the purpose of providing technical support; and
  - CÉnet, to provide support to the diocese. CEnet has access to the personal information from Compass when it is held in CeD3 as well as information collected from other sources and held in CeD3.
- Laws governing or relating to the operation of a school require that certain information is collected. These include: Education Act 1990 (NSW), Health Records and Information Privacy Act 2002 (NSW) and Children and Young Persons (Care and Protection) Act 1998 (NSW).
- Health information about students is sensitive information within the terms of the Australian Privacy Principles (APPs) under the Privacy Act 1988. We may ask you to provide medical reports about students from time to time.
- The CSO and school from time to time discloses personal and sensitive information to others for administrative, educational and support purposes. This may include to:
  - other schools and teachers at those schools
  - government departments
  - the Catholic Education Commission, the school's local diocese and the parish, other related church agencies/entities, and schools within other dioceses
    medical practitioners
  - people providing educational, support and health services to the school, including specialist visiting teachers, sport coaches, volunteers, counsellors
    providers of learning and assessment tools
  - assessment and educational authorities, including the Australian Curriculum, Assessment and Reporting Authority (ACARA), NSW Education Standards Authority, and NAPLAN Test Administration Authorities (who will disclose it to the entity that manages the online platform for NAPLAN).

The CSO's Privacy Policy, accessible on the CSO website, sets out how parents or students may seek access to and correction of their personal information which the school has collected and holds. However, access may be refused in certain circumstances such as where access would have an unreasonable impact on the privacy of others, where access may result in a breach of the CSO or school's duty of care to the student, or where students have provided information in confidence. Any refusal will be notified in writing with reasons if appropriate.
- The CSO's Privacy Policy also sets out how parents and students can make a complaint about a breach of the APPs and how the complaint will be handled.
- 11. The school may engage in fundraising activities. Information received from you may be used to make an appeal to you. It may also be disclosed to organisations that assist in the school's fundraising activities solely for that purpose. We will not disclose your personal information to third parties for their own marketing purposes without your consent.
- 12. On occasions information such as academic and sporting achievements, student activities and similar news is published in school newsletters and magazines, on our intranet and on our website. This may include photographs and videos of student activities such as sporting events, school camps and school excursions. The school will obtain permissions annually from the student's parent or guardian (and from the student if appropriate) if we would like to include such photographs or videos or other identifying material in our promotional material or otherwise make this material available to the public such as on the internet.
- If you provide the CSO or school with the personal information of others, such as doctors or emergency contacts, we encourage you to inform them that you are disciosing that information and why.

# School Student Travel Term 1 2022



School student travel information for parents and students

#### School Travel Passes

Students who need a School Opal card or travel pass but have not yet applied need to apply or update their details as soon as possible.

In the Opal network, students should travel with a Child/Youth Opal card until they receive their valid School Opal card. If outside Greater Sydney, parents should contact their <u>local</u> <u>bus operator</u> to discuss their travel needs.

New Student Opal cards (including new Term Bus Passes) will be sent to the student's nominated postal address within two weeks of their application being approved.

Students living in rural and regional (R&R) areas will receive their travel pass from their nominated transport operator. It may be issued via their school or be sent directly to them at home. Note: some R&R operators do not issue travel passes. Students/parents should confirm with their nominated operator if they do not receive a pass.

#### Terms of Use

Students using Opal cards must tap on and tap off in line with the Opal terms of use.

All students are required to comply with the <u>Student code of conduct</u>. The code of conduct aims to ensure the safety and well-being of school children and other passengers. It is important that parents ensure their child is aware of this, as failure to comply with the code of conduct can result in a suspension from travel.
